## OUR APPROACH

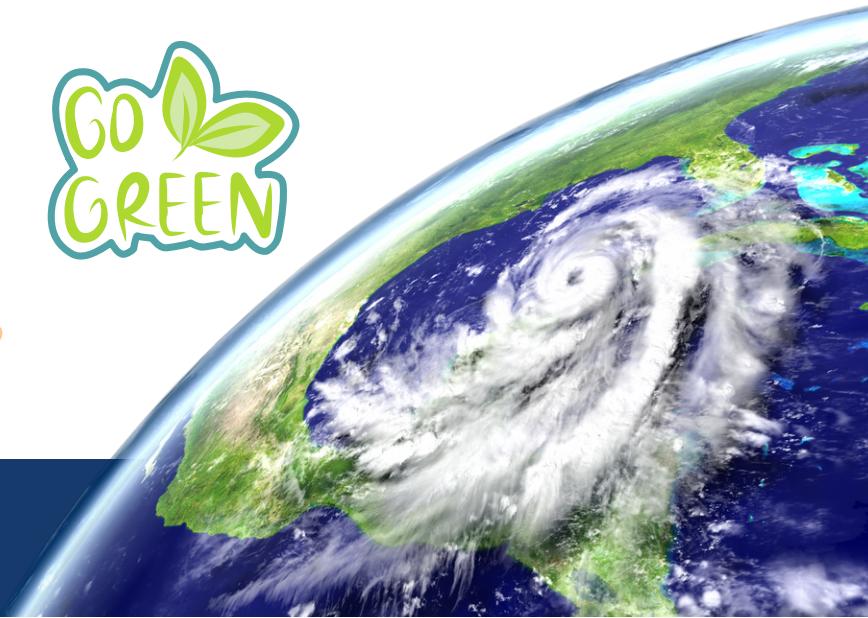
It is a general approach of **SUDOV** to permanently create and maintain projects with the highest possible standards.

**Ecopetrol S.A.** It is a company organized under the form of a public limited company, of the national order, linked to the Ministries of Mines and Energy. It has operations located in the center, south, east and north of Colombia, as well as abroad. It has two refineries in Barrancabermeja and Cartagena. Through its subsidiary CENIT, specialized in hydrocarbon transportation and logistics, it owns three ports for the export and import of fuel and crude oil in Coveñas (Sucre) and Cartagena (Bolívar) with access to the Atlantic, and Tumaco (Nariño) in the Peaceful. CENIT also owns most of the country's oil and polyducts that interconnect production systems with large consumption centers and maritime terminals. **Ecopetrol** also has participation in the biofuels business and presence in Brazil, Mexico and the United States (Gulf of Mexico and Permian Texas).

In the month of October 2023 **SUDOV Fuel & Commodities S.A.** is officially linked as a registered client of **Ecopetrol Colombia** and **REFICAR**, in this way we begin commercial operations connecting our clients with the markets in Colombia and the world.

The commercial function is the last link in the value chain, which connects **SUDOV Group** with the world's markets, seeking to maximize value addition for **SUDOV Fuel & Commodities S.A.** through excellence in the commercialization of crude oil, petrochemical products, gas and energy in a clean, safe and sustainable way, leveraged on human talent, internal optimization, digital tools and the construction of long-term relationships with our clients.
